The Board Member in charge of Environment read out the Municipality Projects done In Musikoma ward in the past and they were acknowledged

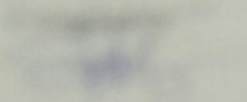
1. Upgrading of Wings wambiya Road and other connected roads

#### Open session.

The members of the public recommended that the following be considered for implementation.

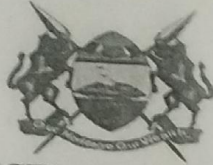
1. Training of coaches and to promote youth mentorship in sports
2. On tourism Developing Namasanda Dam as a tourism center. All the agencies interested in the dam (Financing Locally Led Climate Action Program) FLOCCA National Agricultural Value Chain Development Project (NAVCDP) and FAO to come together and pull resources together and come up with a project that will benefit the citizens.
3. On Education: ECDE at Namono Wekelekha VCT to be equipped with modern tools, Learning materials equipment and Instructors.
4. On Health: Equip the available health centers with medicine and personnel
5. Market Centers to have public toilets,
6. On roads there is need to improve the road networks. Suggested roads include
7. On trade there is need to build a market at Namasanda Junction. Also need to upgrade Sibembe Samoya and Siritanyi Markets. Improve the security in the area
8. On Lands: there is need to buy land at Musikoma or siritanyi for Industrial Park. Resurvey and securing of Namasanda dam, Samoya water spring, former chiefs office (near Musikoma Police Post). Also there is need to buy land for Samoya Market
9. On Agriculture.it was proposed to increase fertilizer distribution to 1000 bags, subsidy on Artificial Insemination (AI). Activation of Agricultural training Institutes.
